#### How to access the vaccine

All legal residents are sent information at home by mail, text message or email with details specific to vaccination location and appointment date. The appointment needs to be confirmed, refused or rescheduled. With valid reasons, at-home vaccination can also be arranged.

It is free of charge.

#### When do the vaccines rollout?

#### January

Residents and staff at nursing homes and medical staff in hospitals

#### February

First-tier medical staff (physicians, pharmacists) and remaining hospital staff

#### March

Patients 65 and older and high-risk patients with comorbidities

#### April

Essential workers

#### June

General population over 18

# Who gets top priority?

- Residents and employees of nursing homes, frontline medical staff exposed to COVID-19 patients, other frontline medical staff.
- Vulnerable population without acute medical care, but at high risk. First population 65 and older, followed by high-risk population between 45 and 65, followed by essential workers.
- C Remaining population.

### Where is a COVID-19 vaccine site?

People are assigned a vaccination site or can be vaccinated at home if they cannot go.

All Indian citizens and expatriates need to register for the COVID vaccine via the Self Registration module called the CoWIN App. The vaccination site will be based on your location and you can choose one that's most convenient.

# Can expatriates get a COVID-19 vaccine locally?

#### Yes.

If you fall into one of these categories listed below.

- Permanent residence (permanencia definitiva)
- Resident visa (visa de residente)
- Student visa (visa de estudiante)
- Other visa per contract or at least a temporary request for visa or visa processing (visa sujeta a contrato o, al menos, una solicitud de visa temporal o definitiva ingresada a trámite)

This does not include if you are in transit or a tourist in the country.

#### How to access the vaccine

The vaccine is voluntary and you must go to a vaccination site on a specific date according to the published vaccination calendar.

You can also be vaccinated in private clinics that have an agreement with the Ministry of Health.

It is free of charge.

## When do the vaccines rollout?

#### The process:

Anyone over the age of 38.

#### The objective:

15 million (80% of the population) by end of June

## Who gets top priority?

- · Health care workers
- · People with comorbidity
- People living in long-term care and elderly care
- People over 65
- · People working in education
- People essential to the administration of the country
